High-Speed Rail Legislative Update

Update: January 29, 2010

Topic: Bills which restructure the CHSRA are moving through committee

This legislative update is sent to city council members, state legislative offices, agencies, local officials and others interested in following high-speed rail's progress. It is a service provided by CARRD, Californians Advocating Responsible Rail Design, to help inform the public of legislative activities related to the HSR project. Three state bills address the future organizational structure of the High Speed Rail Authority and met the deadline of passing through the house of origin. **These are extremely important bills to understand.**

[SB 409](#) (Ducheny) was amended with significant changes; it passed through the Senate yesterday. The focus of the bill has shifted from reorganizing the authority and agency structure to addressing state rail transportation planning. This bill has the potential to significantly improve the coordination of various rail agencies within the state – if it had some teeth. Without incentives this could become a plan for planning a plan; meanwhile, construction of the high-speed rail system will be underway. This bill is merely one step in the right direction. However, the amendment moves away from its earlier address of whether the CHSR Authority is the best organizational body for constructing the project.

Highlights of [SB 409](#):

- Puts the CHSRA within the Business, Transportation and Housing Agency (BTH).
- Requires Senate confirmation of the Governor's 5 appointees to the CHSRA Board.
- Requires the CHSRA to submit an annual funding plan to be submitted to the California Transportation Commission for approval; the plan will identify bond sales necessary.
- Requires the BTH to prepare a 5 year Strategic Rail Connectivity Plan, with the first one due on Sept 1, 2011.
- The Plan will address the coordination and planning of a cohesive, connected system rather than "a cumbersome set of unlinked individual rail services".

Because many of you are familiar with this bill, let's look at how it has changed. The *previous* version of SB 409 reconstituted the authority as a division of a newly formed Department of Rail within the BTH. It addressed jurisdictions of agencies and proposed changes in department responsibilities. The *current* version leaves the authority intact, but within the BTH. Its primary focus is on creating a comprehensive statewide rail plan. I encourage you to read the "Legislative Counsel's Digest" section of [SB 409](#) as amended in the Senate, January 26, 2010.

[AB 1375](#) (Galgiani) has also passed through its house of origin this week. It creates a Department of High-Speed Trains, also within the BTHA. It would direct the development and implementation of intercity high-speed train service, fully integrated with the state's existing intercity rail and bus network. Unlike SB 409, it isn't clear whether the tail (HSR) is wagging the dog (statewide rail network).

Highlights of [AB 1375](#):

- Puts the CHSRA within the Business, Transportation and Housing Agency (BTH).
- Transfers powers of the Authority to that Dept; specifies additional powers.
- The Authority establishes HSR policies for integrating with state's existing rail and bus network.
- Establish an independent peer review group to review planning, engineering, financing, including the funding plan for each corridor.
- Authority's powers and duties would include: route selection; serve as governing body of the Dept; advise BTHA concerning HSR matters and thereupon requires the BTHA to consider such advice; adopt criteria for awarding franchises; set fares.
- Director is appointed by the Governor.
- Gov appoints up to 10 executive employees of the Dept; Authority sets salaries.

To complicate things, [AB 289](#) (Galgiani) was also amended this week to address the structure of the CHSRA. (You'll recall that this was the old grade separation exemption bill.) Because of its urgency clause, it requires 2/3 vote to pass and would take effect immediately.

Highlights of [AB 289](#):

- The Authority shall appoint an Executive Director.
- The Executive Director may appoint necessary staff.
- The Governor may appoint up to 5 Deputy Directors.

In a nutshell, [SB 409](#) continues to include legislative oversight while AB 1375 and AB 289 distance the Authority from legislative involvement. It's worth noting that SB 409 has thus far received unanimous, bipartisan support as it moves through the Legislature. While [AB 1375](#) is also progressing through committees, its support is following party lines. [AB 289](#) cleared the Assembly last year, prior to the amendments. Like AB 1375, it must still pass through the Senate committees.
