**Re: Peer Review of Operations and Maintenance concepts and procedures**

Dear Consul General,

The California High Speed Rail Authority [Authority] signed a Cooperation Agreement with the French Ministry for Ecology, Energy, Sustainable Development and Land Planning with the intent to share and exchange information relative to High Speed Rail, including aspects of technology, standards, funding, planning as well as operations and maintenance, amongst other things. The Authority now has a very definitive need for information or support which we believe could well be covered by this Cooperation Agreement and would like to receive your agreement, or otherwise, as to whether such information can be offered by yourselves.

The Authority has developed Operations and Maintenance concepts and procedures, based on their best knowledge and experience of High Speed systems worldwide. However it is understood that you and the operators within your country have a wealth of experience relating to the operations and maintenance of High Speed Trains. Furthermore it is expected that the operations and maintenance of the California High Speed Rail system could be outsourced to third party operators at a later stage of the project, which would make this exercise even more valuable. The Authority therefore requests from you (and in parallel from other suppliers with similar experience) whether you would be willing and able to conduct a "Peer Review" of our Operations and Maintenance concepts and procedures. This "Peer Review" would entail reviewing and commenting on documentation supplied by the Authority, with the aim to ensure that the operation and maintenance concepts as envisioned by the Authority are logical and feasible and would not result in limitations to the operations if you should possibly operate the system on behalf of the Authority at a later date.

The Authority envisions the following timeline for this review:

- End of September 2010: Submission of the Operations & Maintenance concepts and procedures to yourselves.
- End of November 2010: Return of "Peer Reviewed" documentation to the Authority.


